Cost to attend conference is: \$250 per attendee

By signing this form, the participant and/or parent or guardian agrees that they have read this waiver, understand the terms set forth herein and knowingly and voluntarily agree to the terms of this waiver.

In consideration of my involvement in the program under the auspices of the Howell PAL (and/or its officers, volunteers, staff, sponsors, agents, members and/or activity participants) I hereby agree that:

I acknowledge that by participating in the event put on by the PAL by its very nature:

- 1. I RISK BODILY INJURY, INCLUDING PARALYSIS, DISMEMBERMENT OR DEATH. While the particular rules of the sport, equipment, personal training and discipline may reduce this risk. The risk of injury does exist, as does the risk of damage to or loss of property.
- 2. I knowingly and freely assume all risks both known and unknown, even if arising from negligence of the above mentioned parties.
- 3. I willingly agree to comply with the stated and customary terms and conditions for participants, if however I observe any unusual or unnecessary hazard during my presence or participation, I will bring these incidents to the immediate attention of the nearest Howell PAL Staff/Chaperone.
- 4. For myself, and on behalf of my heirs, those assigned as a personal representative and my next of kin, I hereby: Release, Indemnify and hold harmless and agree not to sue, file a claim for relief or otherwise take legal action against the Howell PAL, their officers, volunteers, staff, or sponsors. Further I and/or my parent/guardian Releases from liability of any of the aforementioned from any liability from any and all injury and loss arising from my participation, whether caused by negligence or otherwise, except that which is the result of gross negligence or wanton misconduct. This indemnification shall include the payment of the Howell PAL's reasonable attorney's fees in defense of any claim filed by you.
- 5. I grant the Howell PAL, its representatives and employees the right to take photographs of my child in connection with the above identified subject. I authorize Howell PAL, its assigns and transferees to copyright, use and publish the same in print and/or electronically. I agree that Howell PAL may use such photographs of my child with or without their name for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and web content.

I have read this Howell Police Athletic League Participation Waiver and fully understand its terms. By signing this Waiver I acknowledge that I have done so both freely and voluntarily. Howell Police Athletic League Youth Leadership Council Code of Conduct

In the interest of creating an environment that is safe and enjoyable for all YLC participants the following discipline policy has been established and will remain in effect at all times during YLC meetings and activities.

- All participants should arrive to all events, meetings and practices on time
- Participants agree to listen to/ follow directions from the YLC Advisors and all other staff and/or volunteers representing PAL.
- Participants will refrain from roughhousing or causing harm to any participants in the program.
- Foul language will not be used nor will it be tolerated by any PAL member at any time.
- PAL members will not indulge in, or encourage anyone to indulge in any conduct that may cause injury or negative reflection upon themselves, the PAL or any other person(s).
- No PAL member shall attend or remain at any underage drinking party, whether it is supervised by an adult or not.
- There is NO SMOKING at any PAL function.
- Proper behavior is required at all times while participating in any PAL related event to include all travel related events.
- The staff has the right to eject or remove <u>anyone</u> from a PAL function. Failure to comply may result in further charges or removal from PAL immediately.
- All injuries must be reported to PAL Advisors immediately.
- All PAL members should be dressed appropriately

If for any reason the above stated rules are not followed, the following steps will be taken, unless of course the severity of the offense requires further disciplinary action.

- 1. First Offense will result in a verbal warning.
- 2. Second Offense will result in the youth being removed from an activity.

3. Third Offense will result in a phone call to the parent/guardian of the youth being suspended from the program and they will be sent home at their own expense.
